Request for Immediate Intervention to Prevent the Demolition of Gurdwara

Guru Nanak Darbar in Shillong

Hon'ble Home Minister,

I write to you in my capacity as a Member of Parliament from Punjab, to bring to your urgent attention the impending demolition of the historic Gurdwara Guru Nanak Darbar, located in the Punjabi Lane area of Shillong, Meghalaya. - 2. The Sikh residents of Punjabi Lane possess land title deeds dating back to 1863, validating their legal claim to the land. Additionally, the Hon'ble Meghalaya High Court has issued a stay order, instructing the authorities to maintain the status quo regarding the property. Ignoring these legal frameworks could have serious implications.
- 3. The Sikh community across India has a deep emotional and spiritual connection with this gurdwara. Any attempt to demolish it could lead to unrest and disturb the peace among a community that has always stood for harmony and unity in India.
- 4. I strongly urge that alternative solutions for urban development be explored, which do not involve the destruction of this sacred site. A constructive dialogue between community leaders and government authorities can help in devising a respectful and mutually agreeable resolution.

Given the sensitivity of this issue, I request that the Ministry of Home Affairs intervene to halt the demolition process and ensure that the cultural and religious sentiments of the Sikh community are safeguarded. Upholding the principles of secularism

and religious freedom that our Constitution embodies is crucial in this matter.

I trust that you will take swift and appropriate steps to ensure that this sacred site is preserved and that a peaceful resolution is reached.
